GENERAL CONDITIONS FOR AFFILIATION OF NEW COURSES

1. The college strictly adhere to the eligibility condition prescribed by the University/Government in admitting candidates for the courses offered and to the said courses.
2. The College should not admit students over the strength sanctioned by the university.
3. No amount should be collected from the students in excess of the fess prescribed by the University/Government or donation for appointment of persons for both teaching and non-teaching position.
4. College should adhere to the Tamil Nadu Government Reservation Policy in admitting candidates and appointment of staff.
5. There shall be no new financial commitment on the part of the, State Government or university on account of the courses being started by the College.
6. The College should pay salary to the teachers as prescribed by the Government / UGC.
7. The College should provide space and facilities to the University to conduct examinations and for other academic purposes as and when required.
8. The Students shall be permitted to appear for the Semester Examinations only after 90 working days from the date of receipt of the affiliation order.
9. The management should get the continuance of affiliation for the above said Courses every year.
10. The management should select the Optional /Ancillary Subject for the above Courses in Consultation with the Controller of Examination of the University.
11. Approved Syllabus can be had from the Board of Studies Section of this University.
12. A sum of Rs.20,000/- under recurring and Rs.50,000/- towards non recurring should be spent towards equipments.
13. A sum of Rs.10,000/- under recurring and Rs.20,000/- towards non recurring should be spent towards Books.



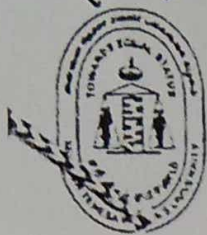

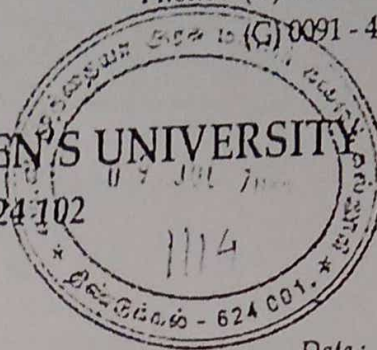
